Planned full-time employment for two years. Planned gross basic salary: PLN 4,000 – 4,100 gross / month. Employment begins: 1 December 2021.

# I. Requirements:

- Specialisation in history of 20<sup>th</sup> century, or 19<sup>th</sup> century, or Auxiliary Sciences of History of 20<sup>th</sup> and/or 19<sup>th</sup> century.
- 2. Ph.D. degree.
- 3. Scholarly achievements (publications and conference presentations in the field of specialisation).
- 4. Additional advantages of the candidates:
  - international relationships;
  - participation in research projects;
  - teaching experience;
  - other achievements and scholarly awards.

# II. Selection procedure:

Application dead-line: 14 October 2021.

The results will be announced by the **2 November 2021**, and candidates will be informed by e-mail. The searching procedure may include interviews with the chosen candidates and a public lecture (on-line) intended for students to test the candidates' teaching skills.

The searching procedure constitutes only the first step in the process of hiring, which is organized according to the procedure provided in the Statute of the University of Warsaw and the relevant rules of the University of Warsaw and Faculty of History.

# III. Description of the responsibilities

1. Conducting scholarly research in the field of history and publishing its results, also internationally.

2. The teaching duties per academic year: 210 hours.

Successful candidate will teach courses of the History of Poland; Universal History; Auxiliary Sciences of History, as well as courses of Academic Writing, and Introduction to the Historical Research.

3. Applying for external research funding (e.g. NCN).

4. Willingness to perform assigned organizational functions in the Faculty of History.

- 4. A CV, list of publications and description of future scientific plans.

- An administrative questionnaire ("<u>Personal questionnaire for the person applying for</u> <u>employment – document docx</u>") to be found at the University of Warsaw Website or contact information if a candidate does not speak Polish.
- 7. Please include in your application the following statement:

"I am familiar with the conditions of conducting a call for the position of an academic teacher at the University of Warsaw (Decree No. 106 of the Rector of the UW of 27 September 2019, paragraph 1, point 4)."

#### Information on personal data processing

# Controller

# Data Protection Officer (DPO)

Controller has designated Data Protection Officer whom you may contact via email at iod@adm.uw.edu.pl. You may contact the DPO in all matters relating to your personal data processing by the University of Warsaw and the exercise of rights in relation to the processing of personal data.

The DPO, however, does not proceed other matters, like handling recruitment procedures, collecting recruitment documents, providing information on current recruitment process.

# Purpose and legal grounds of data processing

Personal data of candidates for employment shall be processed for recruitment purposes only.

Your personal data shall be processed in the scope as indicated by employment law<sup>1</sup> (given name (names) and family name, date of birth, contact information as provided, education, professional qualifications, previous employment) for the purposes of this recruitment process <sup>2</sup>, whereas other data<sup>3</sup> shall be processed based on your consent which may take the following wording:

*I agree to the processing of personal data provided in .... (e.g. CV, cover letter, and other submitted documents) by the University of Warsaw for realising my recruitment process.* 

If your documents include data as mentioned in Art. 9 section 1 of the GDPR (special categories of personal data), processing shall be possible upon your consent to processing such data<sup>4</sup>, which may take the following wording:

*I* agree to the processing of special categories of personal data, as mentioned in Art. 9 section 1 of the GDPR, provided in ...... (e.g. CV, cover letter, and other submitted documents) by the University of Warsaw for realising my recruitment process.

The University of Warsaw shall be also processing your personal data in future recruitment processes upon your consent<sup>5</sup>, which may take the following wording:

I consent to processing of my personal data for the purposes of any future recruitment processes at the University of Warsaw for the period of the next nine months.

You may revoke all such consents at any time by, for example, sending an email at <u>dziekanat.wh@uw.edu.pl</u>. Be advised that the revocation of your consent does not affect legal compliance of processing which had been completed upon consent before its revocation.<sup>6</sup>

# Data retention period

Your personal data collected in this recruitment process shall be stored over the period of three months from the date the recruitment process is completed.

In case you agree to process your data in future recruitments, your data shall be used over the period of nine months.

# Data recipients

Officers authorized by the Controller shall have access to your personal data, the processing of which is in the scope of their duties.

# Data transfer outside the European Economic Area (EEA)

Your personal data shall be disclosed to subjects authorized by law. Signing-in is through Google Forms. Your personal data may be also processed by our provider of G-Suit for education by Google Company in their data processing centres.<sup>7</sup> Your data shall be protected under the standards of the Privacy Shield, accepted by the European Commission.<sup>8</sup> This shall guarantee an adequate level of data security.

# Rights of the data subject

Under the GDPR data subjects have the following rights:

- to access data and to receive copies of the actual data;
- to correct (rectify) your personal data;
- to restrict processing of personal data;
- to erase personal data, subject to provisions of Art. 17 section 3 of the GDPR;
- to file a claim with the President of the Personal Data Protection Office, if you believe data processing violates law.

# Information on the requirement to provide data

Providing your personal data in the scope resulting from law is necessary to participate in the recruitment process. Providing other personal data is voluntary.
