



Call for scholars from Ukraine in the discipline of history at the Faculty of History of the University of Warsaw

Planned duration of stay: 6 months (from as early as May 1, 2022, if possible) Number of places: 3 Covered costs of stay: 3500 PLN (net)

1. Requirements for candidates:

- possession of at least a Master's degree in history;
- experience in conducting scientific research in the field of history (all epochs and specializations acceptable);
- documented research activity;
- an idea for research that can be carried out in the Polish scientific environment;
- legal residence in Poland, obtained on the basis of the provisions of the Act of March 12, 2022 on assistance to citizens of Ukraine in connection with armed conflict on the territory of that country (crossing the border of Poland from Feb 24, 2022).

2. Competition procedure:

- deadline for submission of documents: April 15, 2022 in electronic version to: dziekanat.wh@uw.edu.pl, or in paper version to: Krakowskie Przedmieście 26/28, room 18. <u>Documents can be submitted in Polish, English, Ukrainian or Russian</u>. Please include in the subject line of your e-mail the phrase "historians from Ukraine".
- persons selected on the basis of the documents will be invited for an interview: online or in person (in the Faculty building in Warsaw), depending on the candidates' abilities. The interviews will take place on April 20-26, 2022, in Polish, English or Russian (depending on the candidate's preference).
- the final list of accepted candidates will be announced on April 30, 2022.

3. list of required documents:

- CV and bibliography of scientific works;
- proof of previous scientific activity (e.g. copies of diplomas, publications, links to websites confirming employment in research institutions, links to publications or conference programs, recommendations or contact details of persons who may provide recommendations);
- cover letter including the topic of the planned research (up to 3000 characters);
- a signed statement of consent to process personal data (attachment below).





- 4. Description of duties:
 - conducting scientific research in the field of history within the framework of the submitted topic;
 - cooperation with researchers from the Faculty of History of the University of Warsaw and other milieus;
 - active participation in the scientific life of the Faculty.
- 5. We offer:
 - opportunity to work on one's own research topic;
 - a place to work, access to computers and library;
 - support in acquiring grants from external sources;
 - support in finding accommodation, if possible.





Information on personal data processing

Data Protection Officer (DPO)

Controller has designated Data Protection Officer whom you may contact via email at iod@adm.uw.edu.pl. You may contact the DPO in all matters relating to your personal data processing by the University of Warsaw and the exercise of rights in relation to the processing of personal data.

The DPO, however, does not proceed other matters, like handling recruitment procedures, collecting recruitment documents, providing information on current recruitment process.

Purpose and legal grounds of data processing

Personal data of candidates for employment shall be processed for recruitment purposes only.

Your personal data shall be processed in the scope as indicated by employment law⁹ (given name (names) and family name, date of birth, contact information as provided, education, professional qualifications, previous employment) for the purposes of this recruitment process ¹⁰, whereas other data¹¹ shall be processed based on your consent which may take the following wording:

I agree to the processing of personal data provided in (e.g. CV, cover letter, and other submitted documents) by the University of Warsaw for realising my recruitment process.

If your documents include data as mentioned in Art. 9 section 1 of the GDPR (special categories of personal data), processing shall be possible upon your consent to processing such data¹², which may take the following wording: *I agree to the processing of special categories of personal data, as mentioned in Art. 9 section 1 of the GDPR, provided in (e.g. CV, cover letter, and other submitted documents) by the University of Warsaw for realising my recruitment process.*

The University of Warsaw shall be also processing your personal data in future recruitment processes upon your consent¹³, which may take the following wording:

I consent to processing of my personal data for the purposes of any future recruitment processes at the University of Warsaw for the period of the next nine months.

You may revoke all such consents at any time by, for example, sending an email at dziekanat.wh@uw.edu.pl. Be advised that the revocation of your consent does not affect legal compliance of processing which had been completed upon consent before its revocation.¹⁴

Data retention period

Your personal data collected in this recruitment process shall be stored over the period of three months from the date the recruitment process is completed.

Data recipients

Data transfer outside the European Economic Area (EEA)

Your personal data shall be disclosed to subjects authorized by law. Signing-in is through Google Forms. Your personal data may be also processed by our provider of G-Suit for education by Google Company in their data processing centres.¹⁵ Your data shall be protected under the standards of the Privacy Shield, accepted by the European Commission.¹⁶ This shall guarantee an adequate level of data security.

Rights of the data subject
