# Call for candidates for a position of teaching and research associate professor

# in the Faculty of History University of Warsaw

Full-time employment planned for two years.

Planned gross basic salary: PLN 5400 gross per month

Employment begins: 1 September 2024.

## I. Person specification: essential criteria

- 1. Specialisation in the field of Medieval history.
- 2. Ph.D. degree obtained within the past 7 years.
- Scholarly achievements (publications and conference presentations in the field of specialisation).
- 4. Desirable criteria:
  - international networks;
  - participation in research projects;
  - teaching experience;
  - other achievements and scholarly awards.

## **II. Selection procedure:**

Application deadline: 20 March 2024.

The results will be announced by the 26 April 2024, and candidates will be informed by e-mail.

The search procedure may include interviews with the chosen candidates and a public lecture intended for students to test the candidates' teaching skills.

The search procedure follows the procedure determined in the Statute of the University of Warsaw and the relevant rules of the University of Warsaw and Faculty of History.

III. Description of responsibilities

1. Conducting scholarly research in the field of history and publishing results, also internationally.

2. Teaching duties per academic year: 210 hours.

The successful candidate will teach courses on the History of Poland; Universal History; Auxiliary

Sciences of History, as well as courses on Academic Writing, and the Introduction to Historical

Research.

3. Applying for external research funding (e.g. from the NCN).

4. Willingness to perform assigned organizational functions in the Faculty of History.

IV. How to apply

1. A letter of application (to the Rector of the University of Warsaw).

3. A copy of PhD Diploma or relevant document.

4. A CV, list of publications, and description of future scientific plans.

5. A cover letter.

6. An administrative questionnaire ("Personal questionnaire for the person applying for

employment - document docx").

7. Please include in your application the following statement:

"I am familiar with the conditions of conducting a call for the position of an academic teacher

at the University of Warsaw (Decree No. 106 of the Rector of the UW of 27 September 2019,

paragraph 1, point 4)."

8. The candidates should meet the conditions set out in the Act of July 20, 2018 - Law on Higher

Education and Science (i.e. Journal of Laws of 2023, item 742) and the Statute of the

University of Warsaw (Resolution No. 443 of the Senate of the University of Warsaw of June

26, 2019, Monitor item 190) A letter of application (to the Rector of the University of Warsaw)

#### Information on personal data processing

#### Controller

The DPO, however, does not proceed other matters, like handling recruitment procedures, collecting recruitment documents, providing information on current recruitment process.

### Purpose and legal grounds of data processing

Personal data of candidates for employment shall be processed for recruitment purposes only.

Your personal data shall be processed in the scope as indicated by employment law<sup>9</sup> (given name (names) and family name, date of birth, contact information as provided, education, professional qualifications, previous employment) for the purposes of this recruitment process <sup>10</sup>, whereas other data<sup>11</sup> shall be processed based on your consent which may take the following wording:

I agree to the processing of personal data provided in .... (e.g. CV, cover letter, and other submitted documents) by the University of Warsaw for realising my recruitment process.

If your documents include data as mentioned in Art. 9 section 1 of the GDPR (special categories of personal data), processing shall be possible upon your consent to processing such data<sup>12</sup>, which may take the following wording:

I agree to the processing of special categories of personal data, as mentioned in Art. 9 section 1 of the GDPR, provided in ...... (e.g. CV, cover letter, and other submitted documents) by the University of Warsaw for realising my recruitment process.

The University of Warsaw shall be also processing your personal data in future recruitment processes upon your consent<sup>13</sup>, which may take the following wording:

I consent to processing of my personal data for the purposes of any future recruitment processes at the University of Warsaw for the period of the next nine months.

You may revoke all such consents at any time by, for example, sending an email at <a href="mailto:prace.historia@uw.edu.pl">praca.historia@uw.edu.pl</a>. Be advised that the revocation of your consent does not affect legal compliance of processing which had been completed upon consent before its revocation. 14

### Data retention period

Your personal data collected in this recruitment process shall be stored over the period of three months from the date the recruitment process is completed.

In case you agree to process your data in future recruitments, your data shall be used over the period of nine months.

#### **Data recipients**

Officers authorized by the Controller shall have access to your personal data, the processing of which is in the scope of their duties.

### Data transfer outside the European Economic Area (EEA)
